NOTICE AND CLAIM OF LIEN

TO ALL WHOM IT MAY CONCERN:

Notice is hereby given that the State of Arizona on the relation of the Arizona State Tax Commission, pursuant to Title 42-1335, A.R.S. 1956, (formerly Section 73-1317, A.C.A. 1939, as amended by Laws 1954, Chapter 136, Section 8), hereby claims a lien on all real and personal property of the above-named taxpayer located or situated in the County of Maricopa, State of Arizona, superior to all other liens and assessments placed of record subsequent to the filing of this notice and claim of lien in the office of the County Recorder of said county, except liens for ad valorem taxes, as security for the payment of privilege license tax, penalty, and interest, imposed under the provisions of the Excise Revenue Act of 1935, as amended, in the amounts and covering the period as follows:

Tax.....	\$ 105.12
Penalty.....	\$ 10.51
Interest.....	\$ 3.15
Total tax, penalty, and interest due.....	\$ 118.78

Said tax was imposed on said taxpayer for the privilege of engaging and/or continuing in the rentals business or businesses in the State of Arizona, during the period from November 1, 19 61, to April 30, 19 62, and said tax, penalty, and interest are due and unpaid, and, pursuant to 42-1327, A.R.S. 1956, (formerly Section 73-1315, A.C.A. 1939, as amended by Laws 1954, Chapter 136, Section 7), were finally imposed on the 28th day of August, 19 62, after having accrued on the 21st day of December, 19 61, and thereafter.
